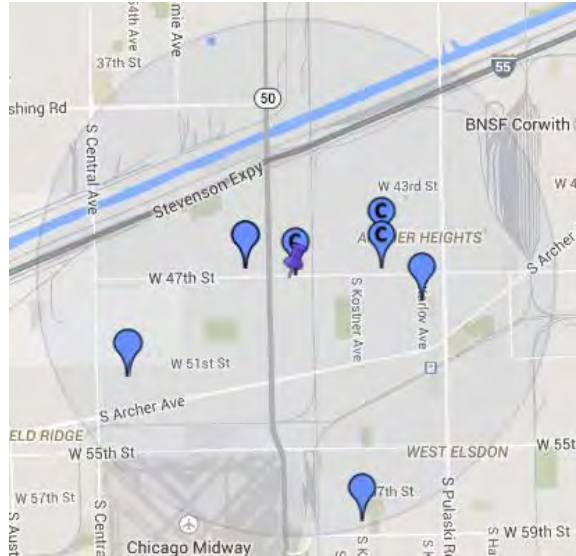
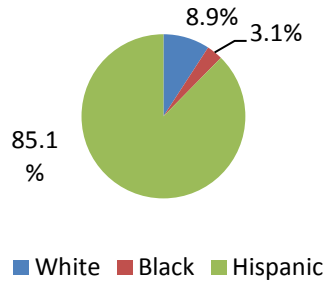
Elementary School

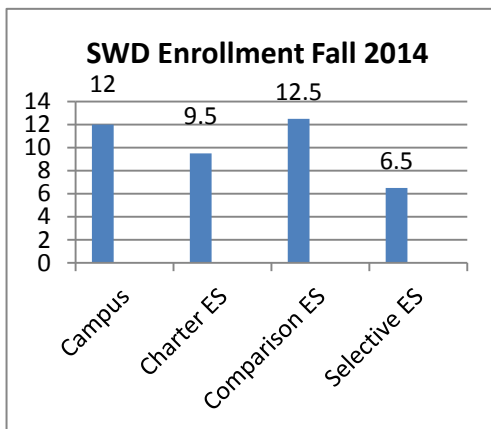

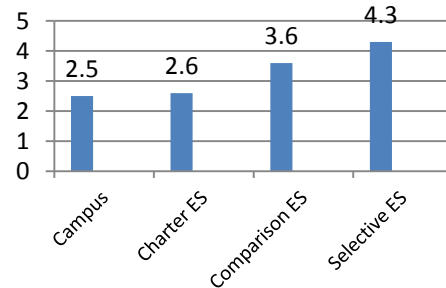
Academy for Global Citizenship is located within 1.5 miles of 6 elementary schools.

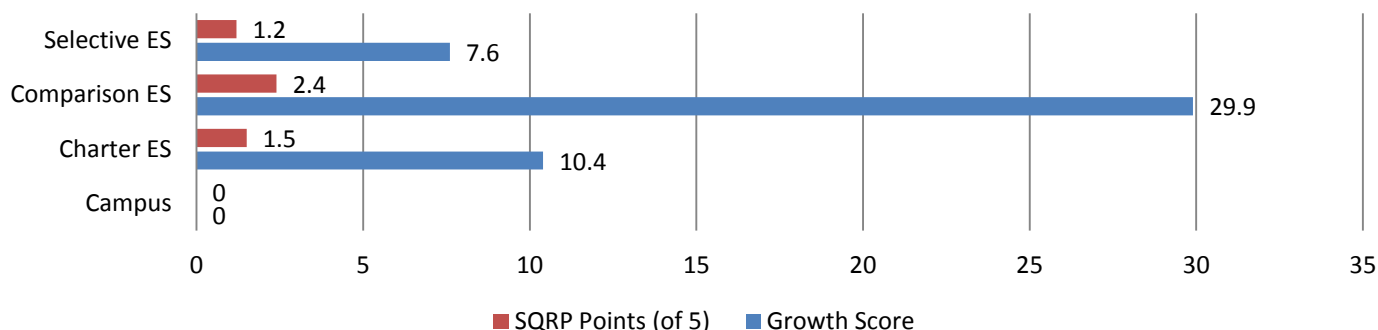

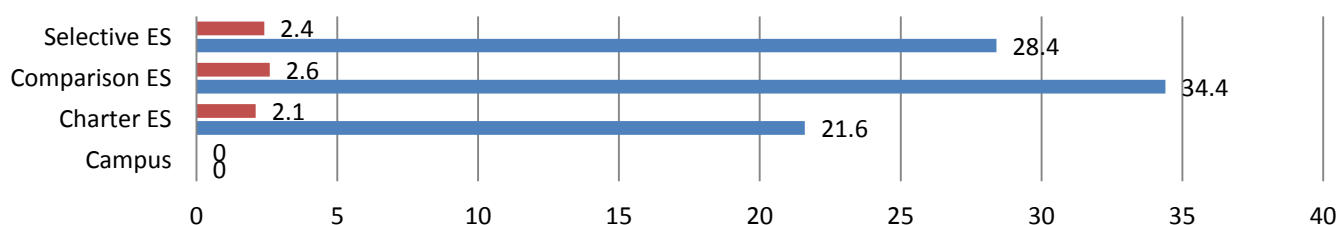

Percent of students who unenroll from the school for any reason

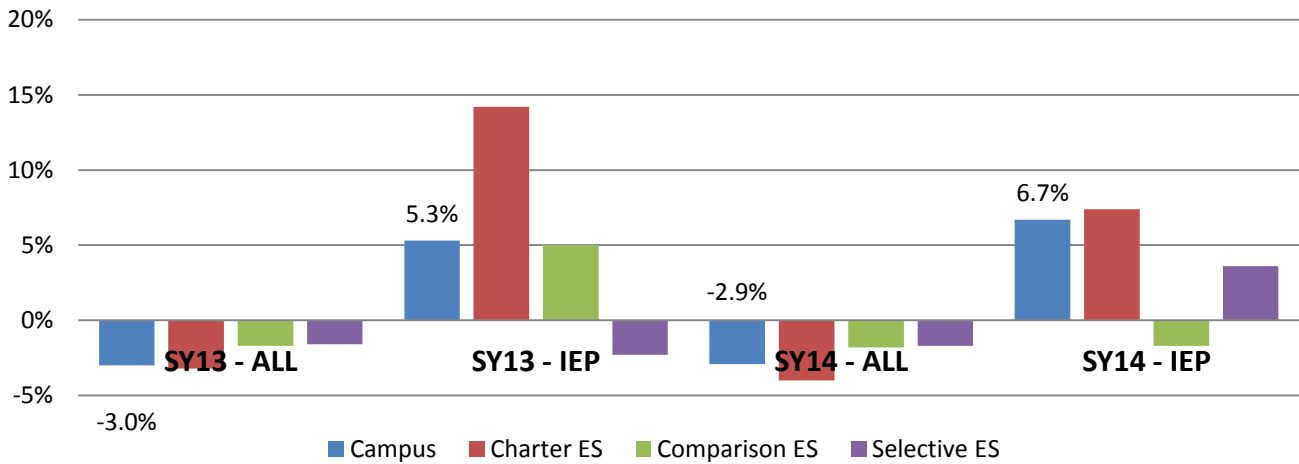

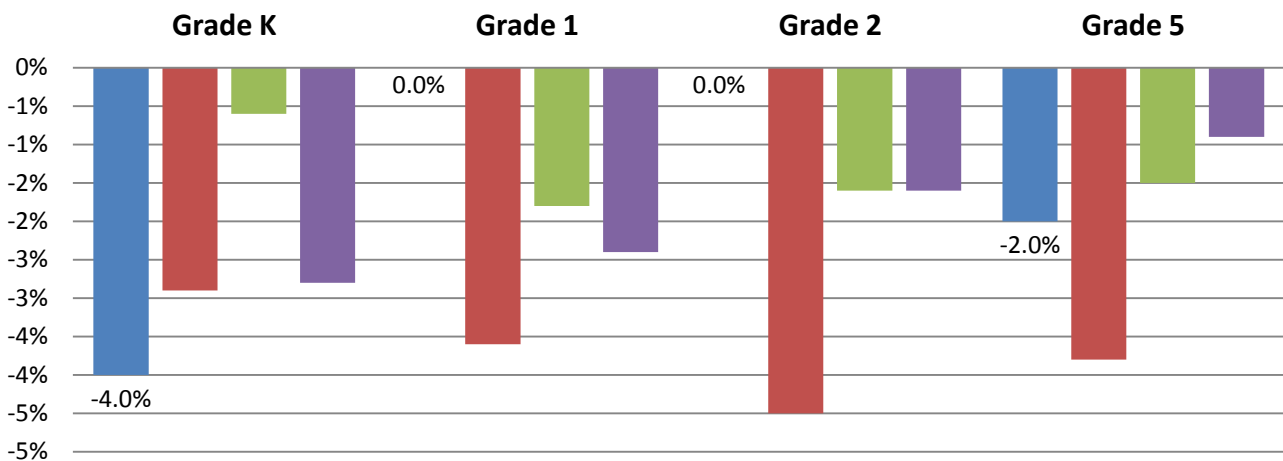

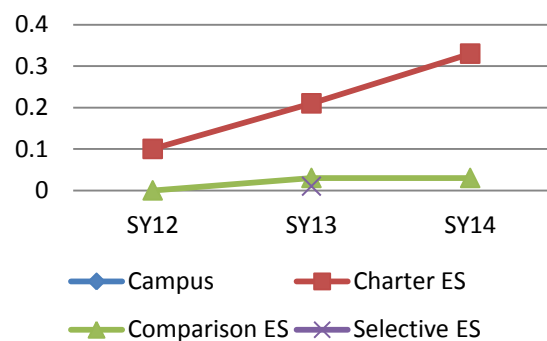
