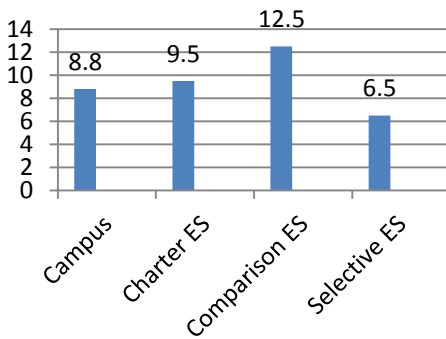

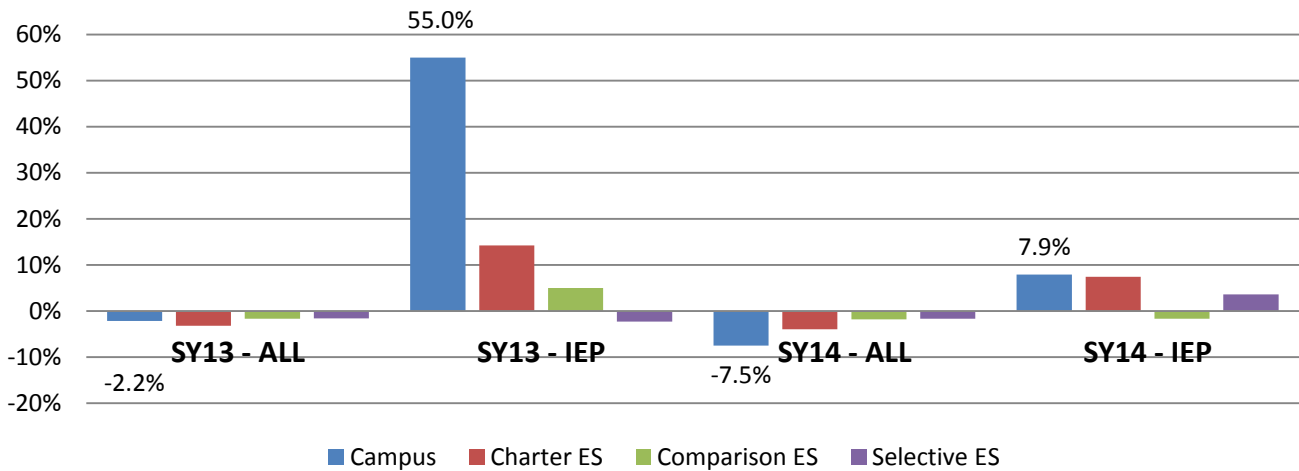

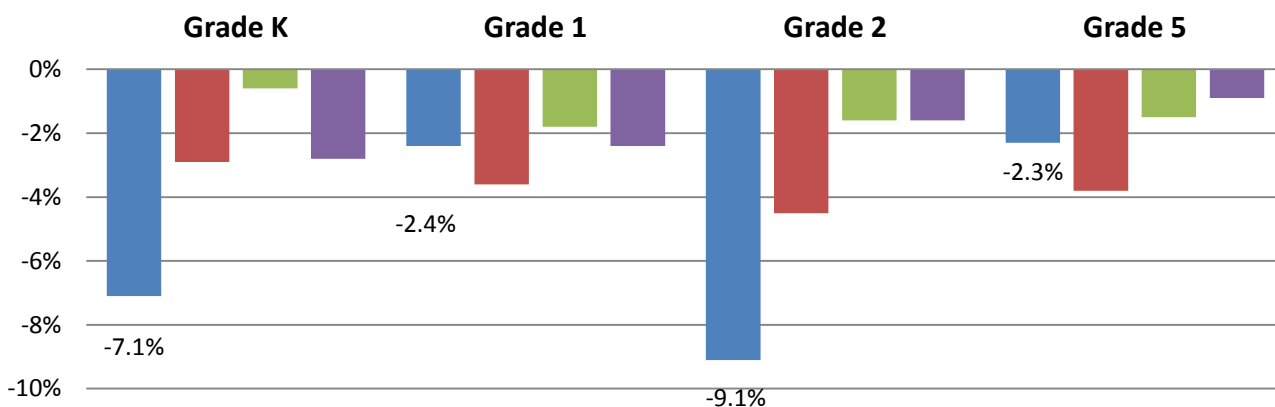

Average Net Enrollment Change during SY 2013-14



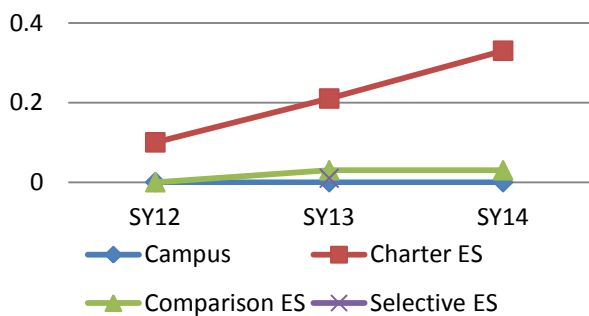
