Applicants for the 2015-2016 School Year will be entered into a lottery, held in June 2015. Submitting your application does not guarantee you a spot for the 2015-2016 school year. Siblings of currently enrolled Passages students will receive preference; however, they must still submit an application and be entered into the lottery.

Pre-Kindergarten

Pre-K applicants for the 2015-2016 school year will be processed on a first come first serve basis. Parents will need to meet with the Pre-K Director and have, in hand, everything listed below. Meetings must be pre-scheduled and will take approximately 30 to 40 minutes. Pre-K is a full day program for four year olds and has a monthly sliding scale tuition fee of \$300. Students must be four by September 1st, 2015 in order to enroll. Siblings of currently enrolled Passages students will receive preference; however, they must still submit an application.
